6. CHAIR'S REPORT.

Everyone is welcomed to the board meeting. Transportation in our state is getting along well. Toll 49 had a single day high of 53,000 transactions on a Friday in May. Houston opened Hwy 288 as a toll road in November. The purpose of the road was opened as a toll road from Brazoria County into downtown Houston. It has brought more revenue as double what was projected. We are fortunate to live in a state that supports these toll projects.

and there were great submissions. The results will be release with much fanfare and advertisement. Second, the billboards are coming, advertising executive have put together for us some billboards and ty commercials. Those are expected in June/July/August in the NET RMA territory. They will be humorous, engaging and fun to look at the get the message out. Mr. Halbrooks asked Glenn or Colleen if he was correct in that he read something about the PR people received awards. Colleen responds he did not. Yes, Haun Public has worked with us just over 2 years and submitted their marketing campaign that they have done for us thus far in reference to using the Toll road and moving transportation forward. They submitted those for several awards, and they received about 4 or 5 awards for their work. We will go over those awards specifically in the next board meeting. But yes, they have already received awards in reference to their work. We are excited for the distracted driving campaign that Mr. Cloutier just mentioned that will come up in June, July and August. There were more than 5,000 agencies that entered, so it is a super competitive campaign. We are excited they are doing great things for us.

C. East Texas Hourglass Committee

We discussed all future segments of Toll 49, both 6, 7 and 8 and topics related to those. At the end of the meeting, it was agreed that the engineers and the staff needed to do more work and that work in underway and there will be another full Committee meeting in July to move those projects forward.

D. Finance Committee

No Report. Treasury is over 1.5% after 10 years. Last time we met the fees were greater than the interest we required. We will continuing to monitor the market.

E. Member Outreach Committee

We are going to talk about priority projects. Normally we accept the applications in March, April and evaluate them and give a recommendation about this time, because of covid and other moving parts, we delayed receiving applications until June 15th. We will be sending out the information on the county judges shortly with the new deadline on it and go through the same process we have for the past 4 years

REVIEW AND ACCEPTANCE OF NET RMA FINANCIAL STATEMENTS. 8.

Dianne Johnston begins with Budget to Actual for October 2020-March 2021. Total Revenue is under budget by 4%. She stated that they still have issues with the TxTag transition. That has not been trued up yet, we expect to have more funds coming to reduce the deficit. For the video revenues and fees exceed the budget by 5%. Total operating revenue overall is just under budget by 1%. Total Operating Expenses is under the budget by 15%. Toll 49 Operating Expenses is under budget by 13%. Total Other income (expenses) is under budget by 5%. Total Net Income is Under Budget 21%. Dianne asked if there were any questions. Robert Messer asked if the reduction in expenses is just a timing difference? Dianne replies that yes, we do have some timing differences.

11. EXECUTIVE DIRECTOR REPORT.

Glenn states he is pleased to inform that we are almost complete with sealcoat. The asphalt surface is down on the roadway on Segment 3B. We are in the process of finalizing the stripping. The first shot of stripping will be a water based paint and will not look as bright as you would expect a brand new job to look. We do that for several reasons, and we will come across it with a final thermoplastic stripe that has glass beads and is highly reflective and add the pavement markers back in 2 weeks after the paint is complete. Also, another item is the yellow center line with a reflective stripe. We will have rumble bars for an additional warning and for the centerline crossing.
