COMMITTEE REPORTS.

Larry Morse – Update on Atkins Supplemental Work Authorization 15 (Gilmer Loop Study)

2nd Stakeholder meeting. Purpose was to review the results of the meeting and through town option was deemed to be to disruptive. It presents the east and was conceptual concepts (Super Two). It also discussed the environmental issues. East has more environmental issues, however, the west route would impact more residences. Atkins also reviews the truck traffic patterns. The two options were reviewed, and the stakeholder preferred the west option. The estimates range to \$200 million to \$275 million. This would remove most the truck traffic through town. There was a total of 30 people in attendance at the December meeting.

Marcia Daughtrey – the east option would be the most expensive option because it goes through so many residential areas.

Larry Morse – Almost all stakeholders agreed that the west option was the best.

John Cloutier (Priority Project Update)

Longview has completed their most recent priority project and are being reimbursed.

7. REVIEW AND ACCEPTANCE OF NET RMA FINANCIAL STATEMENTS.

Dianne – Total revenue is over budget by 6%, total revenue and fees (video, net) is under budget by 28%, total operating revenue is under budget by 6%, total operating expense is over by 27%. Toll 49 operating expenses is under budget by 23%, total other income budget is over by 6%, and total net income is under budget by 4%.

Robert – Are we working on the Audit?

Dianne - Audit is going well but the service reports we have to get are still in progress. We hope we can get them by January and present in March. Auditor has to have these documents.

8. REPORT ON TOLL 49 TOLLING TRANSACTIONS AND REVENUE.

A. COMPREHENSIVE TRANSACTION REPORT BY CDM SMITH.

Justin Wynn – I will be discussing the following regional economic indicators, comparison of Toll 49 with state and nationwide traffic, quarterly trends, daily summary and observed vs. forecasted transactions comparison. For the past 20 years, growth has been about 20%. Smith County is at 50% growth since 2001. Unemployment is at about 4%. Kaufman is the highest growing county. It has been about 1% average growth in the NET RMA counties. Total Transactions for 2022 have been slightly lower than 2021, but only a slight drop. Cars make up most transactions. Trucks have seen strong growth in 2022 and exceed growth in 2021. Long term, the transaction has been positive growth for cars, but Trucks have a stronger growth. On the Daily level, most tracking still slightly below 2021. Historically, 2021 finished below projections, and 2022 is also below, but matched better with 2022 projections.

Robert Messer and Justin have a conversation.

Robert – We are doing better on our trucks than I expected. Should we be charging more?

Justin – This is maybe not my area, but it is something to consider.

CDM Smith - If you raise costs, then trucks will reduce the usage.

Dave – Questions accuracy of charts in board book.

CDM SMITH – The long-term projection numbers have not been updated. 2023 and beyond does not have accurate numbers. 2022 and prior is up to date. We will have accurate numbers next time we meet.

Andrea – Do we have any insight to why are truck transactions have been higher?

CDM Smith – AVI is going up.

Jason Ray – 2021 is higher than 2022?

CDM Smith – 2021 is higher because vacation demand is higher, and people were driving more.

Everett – Higher gas prices also explain it.

Kami Bailey – This is our fun Santa campaign to show you can avoid holiday traffic. (Shows Santa video) Short but sweet. David – Harrison County Grant (positive coverage video). We are always excited to promote the grant projects and work with local media to get positive media.

Kami – Safe driving campaign in radio, billboards, gas pumps, etc. Overall Digital performance was high and topped averages. Radio had a decrease rate for click rate. Social on Facebook last year was organic, and there was a significant increase in this advertisement. Twitter was not the focus of our campaign and did decrease probably due the to the changes in

twitter. Website performance was good and above the industry standard. Majority was viewed from the phones and tablets. Lastly, our future recommendations are to move on to something new to top the campaign we had this year.

David – 2023 Linda Thomas Safe Driving Scholarship – We are doing 10 \$1,000 scholarships. We had about 70 students apply last year and get moving a little sooner this year.
