5. DISCUSSION, CONSIDERATION AND APPROVAL OF THE MINUTES FOR THE JANUARY 7, 2023 REGULAR BOARD MEETING.

6. COMMITTEE REPORTS.

Andrea – Linda Thomas Safe Driving Scholarship is now open. We expect a good response, so please share with your community.

7. REVIEW AND ACCEPTANCE OF NET RMA FINANCIAL STATEMENTS.

Dianne – Total revenue is over budget by 13%, total revenue and fees (video, net) is under budget by 27%, total operating revenue is under budget by 1%, total operating expense is over by 23%. Toll 49 operating expenses is even at 0%, total other income budget is over by 3%, and total net income is over budget by 26%. I am pleased with where we are right now. On page 21 of your board book, this is the quarterly break down our investments I am required to give you.

Difference in video. Should we be concerned with that?

Dianne – At this time, I am not concerned, but I will be watching. It is due to the fees and the delay with NTTA.

8. REPORT ON TOLL 49 TOLLING TRANSACTIONS AND REVENUE.

Dianne – Here is the chart of daily averages. You can see that our January transactions do go down, but the average for January was \$36,205. The average though is still higher than all of our other reported January months.

Larry Kellam – 2022 appears to be running lower than 2021. Is there a reason for that?

Dianne – This drop was probably due to gas prices and overlay work that we had done.

(RESOLUTION 23-05) Action Item

Glenn – This has gone to the board in the past, but we had to update some construction plans. The board has already passed one resolution, but TXDot had an issue with the plans. This is a project we need to do for safety reasons.

(RESOLUTION 23-06) Action Item

Glenn – This is an item that is a great opportunity for the NET RMA. The city of Terrell wants us to assist with a development area by Buc-ee's. Our part would just be the roadway. This is a project we are pressuring because we can give them a cost-effective way compared to other sources. There are some other fees that we have not 100% hammered out, but Terrell is willing to back stop in case it does not develop in the time frame expected. Overall, I see this as a plus, and it does not have a lot of risk. In order to move forward, I need to submit a bank loan as the best option per our financial advisors. This resolution would be to start formally moving forward with the project. Questions?

Dan – Does it go all the way to I-20, or does it stop?

Glenn – We will go all the way to I-20 but will 100% be the city and TXDot will not be involved.

Nathan – What are the interest rates?

Glenn – I don't have those right now but will get them to you.

Matthew Watts – Will the city take over?

Glenn – Yes, they will take over all future maintenance?

Andrea – I saw an article, but that Kaufman is the fastest growing county, so this is a huge opportunity for us based on all the growth.

11. EXECUTIVE DIRECTOR'S REPORT.

Glenn – We currently have a RFQ for our GEC. I forget the numbers, but we have 27 that have looked at it so far. There is a lot of good competition and attention. With us today is Donna Adams with Atkins. They are readily capable and available to meet our needs. Our GEC contract expires in May. HNTB is our other GEC.

- C. Section 551.074. Personnel Matters—Deliberation concerning the appointment, employment, reassignment, evaluation, duties, discipline, and/or dismissal of personnel.

PARTICIPATION BY TELEPHONE CONFERENCE CALL:

One or more members of the Board may participate in this meeting through a telephone conference call, as authorized by Section 370.262, Texas Transportation Code. Under that law, each part of the telephone conference call meeting that by law must be open to the public shall be audible to the public at the meeting location. During the meeting, the identification of each party shall be clearly stated prior to speaking, and the meeting shall be documented by written minutes. On conclusion of the meeting, the written minutes of the meeting will be made available to the public.
