6. DISCUSSION, CONSIDERATION AND APPROVAL OF THE MINUTES FOR THE JULY 12, 2022 REGULAR BOARD MEETING.

7. COMMITTEE REPORTS.

Andrea – Sometimes it is good take a moment to bring up some positive events, and I think this is heartwarming and good to share with the board. We initiated the Linda Thomas Safe Driving Scholarship, and we opened this scholarship to all students in the 14 counties of the NET RMA. We had a fantastic response and had about 75 applications for 10 scholarships. We received this handwritten note in the past month. This note is from Gavin Bailey who goes to a small school named James Bowie, and he is an amazing kid. All our recipients were amazing students. Students and parents were all grateful.

8. REVIEW AND ACCEPTANCE OF NET RMA FINANCIAL STATEMENTS.

Dianne – Total revenue is even, total revenue and fees (video, net) is under budget by 11%, total operating revenue is under budget by 4%, total operating expense is even. Toll 49 operating expenses is over budget by 7%, total other income budget is over by 3%, and total net income is under budget by 6%.

Dianne also discussed that we had a delay in invoices till July and due the first part of August. NTTA is still in the rampart of collections, there was also an additional expense to pay to Kapsh.

Larry – You mentioned a delay in collections, due you have an idea of the amount?

Dianne – We are still in the ramp up, so I am not sure 100%.

- 9. DISCUSSION, CONSIDERATION AND POSSIBLE ACTION TO APPROVE THE NET RMA 2022-2023 BUDGET. (RESOLUTION 22-15) Action Item
- Gary The budget starts with Dianne, then the Finance Committee, then the executive Committee, and then it comes to the Board today. I want y'all to know that this the process. I appreciate Dianne and Glenn since this is a laborious process each year.
- Glenn I would like you to know is our controller went through a lot of data to establish the best budget possible. We have been through our final version, which is version 6. I will let Dianne go through the budget.

10. TOLL 49 SYSTEM TRAFFIC AND REVENUE REPORT.

Justin – I am with CDM Smith. Toll 49 is a limited access toll road and was open in segments starting in 2010. The current rate is \$0.207 per mile plus an addition surcharge for pay by mail. Historical trends show that growth is consistent but was affected by covid. If we look solely at trucks, we jumped back very quickly.

Andrea – Our truck traffic is about the same in compared to the whole country, but passenger traffic?

Justin – Yes, passenger traffic is lagging. Toll 49 is not a commuter toll road. Lowest segment is segment 4. There is not a lot of full distant trips. 72% of users are just using the road just 1 day a week.

Questions

Larry Morse - About a 20% reduction?

Justin – Yes, by 2055 it is about 20% change.

- Matthew Watts Why is there a reduced rate of growth?
- Justin It's just a lag in economic growth due to COVID and other factors. It will be heavily affected by population.

Larry Kellam – Does fuel affect this?

Justin – Not really, but overall inflation could be a factor.

CDM Smith

Andrea – This is an overall Trend?

Justin – Yes, this is an overall trend.

Andrea – Are there other areas in the state that are higher than 2019?

Justin – Yes, but everywhere is still lower than what is expected. There are more people working from home than before.

Larry Morse – What is the region that is defined in your study?

Justin - Showed map of the Region presented in slide

11. PRESENTATION ON SAFE DRIVING CAMPAIGN.

- Kami If you recall we worked with Chet the Day Tripper, and here a few of the ads in the slide. In total, Chet shared 11 posts for us. Overall, they were very successful. Glenn – They mainly handle the electronic toll maintenance, oversight of that system, accuracy, counting toll transaction, monthly maintenance reviews, and a large amount of technical supports. Staff recommends approval of this work authorization.

- Glenn Sice is our new toll integrator and providing equipment on the gantries. The amount is in accordance with the estimate they provided us. Staff recommends approval of this work authorization.

Chet – Do we have to approve this every year or overall?

Glenn – We thought it was a little cleaner to approve a yearly budget out of the 2 million amount instead of a onetime approval.
