

## **NET RMA Terms and Conditions**

The North East Texas Regional Mobility Authority (“NET RMA”) is an independent government agency created to accelerate the development of infrastructure projects in North East Texas. The NET RMA website ("Site") is provided for the benefit of authorized users including you.
