WHEREAS, it is necessary and desirable to develop and adopt a budget for NET RMA operations at the commencement of each fiscal year; and

WHEREAS, the 2022–2023 fiscal year ends on September 30, 2023; and

WHEREAS, the NET RMA has developed a budget for fiscal year 2023–2024 ("FY 2024"), attached hereto as Attachment "A."

NOW THEREFORE, BE IT RESOLVED, that the NET RMA Board of Directors approves the budget for FY 2024, attached hereto as <u>Attachment "A"</u>; and

BE IT FURTHER RESOLVED that this budget may be amended from time to time with the approval of the Board of Directors.
