RESOLUTION NO. 16-93

WHEREAS, the North East Texas Regional Mobility Authority ("NET RMA") was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, et seq. (the "RMA Rules"); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman joined the Authority and are represented on the Board of Directors; and

WHEREAS, the NET RMA is responsible for the operation of Toll 49; and

WHEREAS, the NET RMA is currently pursuing the development of Segment 4 of Toll 49 (the "Project"); and

WHEREAS, on March 1, 2016, in Resolution 16-21, the Board of Directors authorized the Interim Executive Director to enter into a contract for the construction of the Project with Webber, LLC ("Webber") in the amount of \$68,760,000 (the "Contract"); and

WHEREAS, the Texas Commission on Environmental Quality required the preparation of a Storm Water Pollution Prevention Plan ("SWPPP") for the Project; and

WHEREAS, NET RMA consultants have determined that additional erosion control measures are needed to ensure compliance with the SWPPP and recommend the approval of Change Order No. 4.0 to the Contract, attached hereto as <u>Attachment "A"</u>, for an amount not to exceed \$200,431.31 to provide for such additional erosion control measures.

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors approves Change Order No. 4.0 in the form or substantially the same form attached hereto as <u>Attachment "A"</u>, for an amount not to exceed \$200,431.31; and

BE IT FURTHER RESOLVED, that all work performed under Change Order No. 4.0 shall be subject to the Contract between the NET RMA and Webber and that no additional work may be undertaken without the specific approval of the Board of Directors.

Description and Reason for the Change Order

This change order is necessary to incorporate additional erosion control measures to ensure SWPPP compliance. The unit price items shown in Table 1 below will be added as Extra Work Items included in the contract.

The Rock Filter Dams are necessary to allow the use of rock berms to decrease the flow intensity of potential runoff while reducing the risk of silt from moving onto adjacent property and will assist in controlling sediment within the Right of Way.

The Floating Turbidity Barrier is being added as additional temporary sediment containment devices necessary to prevent sediment-laden water from escaping the immediate work area and entering adjacent bodies of water during construction activities.

Additional construction exits are being added control offsite tracking of sediment from vehicles leaving the site.

A Force Account items for Erosion Control Maintenance is being added. All work under this item shall be in accordance with Item 506 of the TxDOT Specifications and payment shall be made per Article 6.5.2.
