GENERAL MEETING OF THE BOARD OF DIRECTORS OF THE NORTH EAST TEXAS REGIONAL MOBILITY AUTHORITY

RESOLUTION NO. 17-03

WHEREAS, the North East Texas Regional Mobility Authority ("NET RMA") was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, et seq. (the "RMA Rules"); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman joined the Authority and are represented on the Board of Directors; and

WHEREAS, in Resolution No. 11-05, dated February 28, 2011, following a competitive procurement process, the NET RMA Board of Directors approved the selection of Telvent USA Corporation, now known as Kapsch TrafficCom Transportation NA, Inc. ("Kapsch"), as the best qualified firm to serve as toll systems integrator to the NET RMA and authorized the Chairman or his designee to negotiate and execute an agreement with Kapsch for the provision of such services (the "Agreement"); and

WHEREAS, in Resolution No. 16-75, dated August 9, 2016, the NET RMA Board of Directors exercised the option to renew the Agreement between Kapsch and the NET RMA for one additional three (3) year period; and

WHEREAS, the Agreement may be amended from time to time through change orders agreed upon by the NET RMA and Kapsch; and

WHEREAS, the NET RMA and Kapsch have agreed to a change order to provide for toll system equipment replacement on Segments 1 and 3B of Toll 49; and

WHEREAS, Kapsch has developed a proposed scope of services and a budget of \$122,862.47 for toll system equipment replacement on Segments 1 and 3B of Toll 49; and

WHEREAS, a copy of that proposed scope of services and budget is contained in Change Order No. 12, attached hereto as Attachment "A"; and

WHEREAS, considering the Agreement, previously approved Change Order Nos. 1 through 11, 13, and 14, and proposed Change Order No. 12, the maximum amount to be paid for services under the Agreement is approximately \$8,134,879.22; and

WHEREAS, the Board of Directors must approve Change Order No. 12 before Kapsch may proceed to work thereunder; and

WHEREAS, Kapsch has represented to the Board of Directors that the work reflected in Change Order No. 12 is necessary and appropriate.

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors approves Change Order No. 12 in the form attached hereto as <u>Attachment "A"</u>, for an amount not to exceed \$122,862.47; and

BE IT FURTHER RESOLVED, that all work performed under Change Order No. 12 shall be subject to the Agreement for Toll System Integration Services between the NET RMA and Kapsch and that no additional work may be undertaken without the specific approval of the Board of Directors.
