

**GENERAL MEETING OF THE BOARD OF DIRECTORS  
OF THE NORTH EAST TEXAS  
REGIONAL MOBILITY AUTHORITY**

**RESOLUTION NO. 18-01**

WHEREAS, the North East Texas Regional Mobility Authority (“NET RMA”) was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, *et seq.* (the “RMA Rules”); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman joined the Authority and are represented on the Board of Directors; and

WHEREAS, the Commissioners Courts of Cass and Camp Counties have adopted resolutions requesting that each county be allowed to join the NET RMA; and

WHEREAS, the Texas Department of Transportation has adopted rules for the addition of counties to a regional mobility authority, set forth in Section 26.21 of the RMA Rules; and

WHEREAS, if approved by the NET RMA Board of Directors and the Commissioners Courts of Gregg, Smith, Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman Counties, a petition requesting approval for Cass and Camp Counties to become part of the NET RMA will be submitted to the Texas Transportation Commission in accordance with Section 26.21 of the RMA Rules; and

WHEREAS, pursuant to Transportation Code Section 370.251 and the Bylaws of the North East Texas Regional Mobility Authority, the addition of Cass and Camp Counties will allow each of those two (2) counties to appoint one (1) member each to the NET RMA Board of Directors, with any additional appointments by a process unanimously agreed to by the commissioners courts of all the counties of the NET RMA; and

WHEREAS, the NET RMA Board of Directors has considered the request of Cass and Camp Counties to join the NET RMA and has determined that the addition of Cass and Camp Counties will benefit the mobility of the region and will facilitate regional planning and development of critical transportation infrastructure, thereby enhancing economic vitality and promoting a better quality of life for residents throughout North East Texas.

NOW THEREFORE, BE IT RESOLVED, that the NET RMA Board of Directors agrees to the addition of Cass and Camp Counties to the NET RMA, subject to securing the approval of the Commissioners Courts of Gregg, Smith, Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman Counties; and


BE IT FURTHER RESOLVED, that the NET RMA Board of Directors and the NET RMA Executive Director are authorized to take such actions as are necessary to secure approval of the Texas Transportation Commission to the addition of Cass and Camp Counties to the NET RMA; and


BE IT FURTHER RESOLVED, that the NET RMA Board of Directors commends the Commissioners Courts of Cass and Camp Counties for their foresight and commitment to regional planning, mobility improvements, and regional cooperation that can be accomplished through participation in the NET RMA.
