

**GENERAL MEETING OF THE BOARD OF DIRECTORS
OF THE NORTH EAST TEXAS
REGIONAL MOBILITY AUTHORITY**

RESOLUTION NO. 19-12

WHEREAS, the North East Texas Regional Mobility Authority (“NET RMA”) was created pursuant to the request of Gregg and Smith Counties and in accordance with provisions of the Transportation Code and the petition and approval process established in 43 Tex. Admin. Code § 26.1, *et seq.* (the “RMA Rules”); and

WHEREAS, the Board of Directors of the NET RMA has been constituted in accordance with the Transportation Code and the RMA Rules; and

WHEREAS, subsequent to the initial formation of the NET RMA the Counties of Cherokee, Rusk, Harrison, Upshur, Bowie, Panola, Titus, Van Zandt, Wood, and Kaufman joined the Authority and are represented on the Board of Directors; and

WHEREAS, on March 6, 2019 the NET RMA issued an Invitation to Bid for the Toll 49 Seal Coat Project; and

WHEREAS, pursuant to Section 5 of the NET RMA Policies and Procedures Governing Procurement of Goods and Services, the contract must be awarded to the lowest responsible bidder that complies with the NET RMA’s criteria for the contract; and

WHEREAS, in Resolution No. 19-06, dated February 12, 2019, the Board of Directors of the NET RMA authorized the Executive Director to enter into a contract for the Toll 49 Seal Coat Project with the contractor determined to be the lowest responsible bidder, provided that the contract price did not exceed the NET RMA’s General Engineering Consultant’s estimated price plus 10%; and

WHEREAS, all bids received exceeded the General Engineering Consultant’s estimated price of \$1,285,838.87; and


WHEREAS, the lowest responsible bidder was determined to be Longview Bridge and Road, Ltd. with a total bid of \$1,315,757.55; and

WHEREAS, the General Engineering Consultant recommends entering into a contract with Longview Bridge and Road, Ltd. for the Toll 49 Seal Coat Project in an amount of \$1,315,757.55 plus a 10% contingency, for a total of \$1,447,333.30.

NOW THEREFORE, BE IT RESOLVED, that the Board of Directors of the NET RMA hereby authorizes the Executive Director to enter into a contract for the Toll 49 Seal Coat Project with Longview Bridge and Road, Ltd. in the amount of \$1,447,333.30.
