3. CONDUCT ANNUAL WORKSHOP FOR PREPARATION OF FY 2017 NET RMA BUDGET

Discussion ensued regarding budgetary issues. There was lengthy discussion regarding the increased number of employees (increased by 3FTE: receptionist, jr. engineer and a finance person), the Priority Project amount that was budgeted (\$400K) and the hefty amount of money spent on attorney fees. Ultimately, hiring of three new employees/salaries was agreed upon, the Priority Project was increased to \$500K. The board agreed this amount would be revisited later on in the year and increased if revenues were favorable. There was also discussion on use of local attorneys for minor legal matters, with Locke Lord providing oversight or only handling large, complicated matters, managing this budgetary line item down from what is has been in the past.

There was also several requests for a 5-year cash flow plan, to ensure the budget would be reflective of the 5-year plan of the agency. A 5-year plan will be provided at the next regular board meeting.
